Procedure

- Dissolve Skin Save in Water, then add Glycerin and preservative and mix until uniform and clear.
- Add successively the components of phase B into A and mix until uniform and clear.
- Adjust pH to 4.8–5.2 with citric acid.
- Measure viscosity and add 0.1 % increments of Sodium Chloride until desired viscosity is reached.

Stability

Product was stable during 4 weeks with repeated cycles from 5 °C to 40 °C
