Procedure

- a) Dissolve the components of phase A in water.
- Disperse phase B and add to the water-phase (A). Mix well until a uniform and clear gel is obtained.
- d) Adjust pH to 5.5-6.5 with citric acid (C).

Product was stable during 4 weeks with repeated cycles from 5 °C to 40 °C
