#### Procedure

- Fill water and hyaluronic acid (1+2) into container and mix well till homogeneous gel is created (approx. 10-20 minutes).
- Add other ingredients (3,4,5,6,7) step by step and stir well.
- Measure pH. The permitted range is 5,5 - 6,5.
- In case of low pH set up the value by citric acid (9).
- Add chelating agent (8) to the product and stir well to dissolve it.

product was stable during 4 weeks with repeated cycles from 5°C to 40°C
